

**PEACHTREE ROAD RACE 2005**  
**Waiver, Indemnification and Hold Harmless Agreement**  
**For Wheelchair Participants**

For and in consideration of the acceptance of my entry in the Peachtree Road Race held on July 4, 2005, the undersigned agrees and certifies as follows:

1. The undersigned is physically fit and has sufficiently trained to participate in this 6.2-mile road race event.
2. The undersigned understands that participation as a wheelchair participant in the Peachtree Road Race is an activity that carries inherent risks of personal injury. Undersigned understands that the race is conducted on state, county, and city streets, and this condition may create the potential for personal injury. The undersigned also understands and acknowledges that this event was not specially designed for wheelchair participants and that there is no representation, certification, or warranty that this course is suitable for wheelchair participation. Undersigned does hereby, for myself, my heirs, my administrators and executors, forever waive, release and/or discharge The Atlanta Track Club, Shepherd Center, any other sponsor(s), officials, members, or volunteers for any injuries sustained arising out of my association with entry in, or participation in the Peachtree Road Race.
3. That undersigned further understands and agrees that because of the inherent risks of participating as a wheelchair participant in the Peachtree Road Race, that I will take special precautions to avoid injuring others including but not limited to wheelchair participants, runners, volunteers, or spectators, such precautions to include yelling loudly to signal those ahead, swerving to avoid contact, and, if necessary, braking whenever necessary or appropriate. Undersigned agrees also to take special precautions to avoid contact and inconvenience to any vehicles and their drivers who may be on the race course during the event.
4. In consideration for my entry in this event, I hereby agree to indemnify and hold harmless The Atlanta Track Club, Shepherd Center, its sponsors, officials, members, and volunteers, from any claims, demands, suits, or loss which may result from any act or omission which I may commit while participating in this event.
5. Undersigned agrees to abide by all instructions from race officials and, if requested by the race director or any other official, to withdraw from the race in the event that such person in his or her sole judgement and discretion determines that my participation poses a threat to the safety of myself or others or in the event that I do not abide by any instruction of a race official.
6. In consideration of my entry, the undersigned grants full permission to The Atlanta Track Club, Shepherd Center and any sponsors to use any photographs, video tapes, motion pictures, recordings or any other record of the event for any purposes which it may elect, including any commercial or promotional purpose, and that I will not seek or be entitled to any compensation or remuneration for any such use.
